

SMART goals:

Specific - Identify what you want as an outcome. Keep it tight.

Measurable - Decide on how you will know when you have achieved this.

Attainable - Identify your steps and any challenges you may face.

**R**elevant – Is this a priority for you right now and if so why?

**T**imebound - Decide on a date that you want this completed to keep yourself on track.

#### **One Check**

Use One Check to find out if a business name is available and not registered to someone else.

#### Company name registration

Register your company name with the Intellectual Property Office of New Zealand (IPONZ).

Own your limited liability company, cooperative company, unlimited company idea. (PDF 262 KB)

#### Domain name registration

Register your domain name with IPONZ.
